



## Strong performance in Q3

### Revenue up 8.6%

### French staffing growth up + 12.4%

### Q3 YTD growth above 10%

Groupe CRIT delivered a strong third quarter posting revenue of € 565 million vs € 520.4 million in Q3 2015. The group posted growth of 8.6% despite a high comparison basis (Q3 2015 up 12.7%). Thanks to this new successful quarter, revenue for the first nine months of the year amounted closed to € 1.6 billion, rising by 10.5%.

### Staffing & recruitment division: + 11.2%

Staffing & recruitment division (85.2% of total revenue) posted cumulated revenue of €1 353.3 million, up 11.2%. The third quarter contributed to this strong performance with revenue amounting to €479.1 million, up 8.9%.

#### France : organic growth above 14%

Following an increase above 15% in H1 2016, French staffing division confirmed its sustained growth in Q3 with revenue amounted to €368 million, rising by 12.4%.

For the first nine months of the year, French staffing activities recorded an organic growth up above 14% to €1 029.6 million, more than twice the market growth (up 6.3% on the 8 months ended August - source Prism'emploi).

Thus, quarters after quarters, the Group continues to outperform its market and confirms its capacity to gain new market shares

#### International growth

In Q3, International operations revenue amounted to €111.1 million vs €112.7 million in 2015. Despite this slight decline due to U.S. market conditions still contrasted, international activities posted revenue of € 323.7 million, increasing by 3.0% for the first nine months of the year.

## Multi-services division : strong dynamics in France

For the first nine months of the year, Multi-services division posted revenue up 6.1% to € 249.9 million<sup>(1)</sup>. Airport activities (74.1% of activity of the division) continue to perform well with cumulated revenue of €184.8 million, up 4.9%. The third quarter growth has been particularly strong growing by 7.1%, driven by the activity in France posting growth up 12.3% in Q3.

In view of this successful third quarter, the group remains confident for the end of the year and confirms its objective to exceed 2 billion euros in revenue in 2016.
