



Q2 2010 sales : + 19.9%

In Q2 2010, Group Crit sales amounted to € 331.8 million, up to 19.9%. In H1 2010, sales were up to € 605.5 million, an increase of 14.7% compared to H1 2009. This noticeable performance confirmed, as expected, the recovery observed by the group in the last months both in its Temporary business segment and Airport activities.

Temp. business : +19.1%

In Temp. business, Q2 sales amounted to € 277,1 million⁽²⁾, up to 19.1%. This strong increase is at constant scope. The activity in June recovered strongly with an increase in sales closed to 21%.

France and international contributed to this good second quarter:

- In France, sales amounted to € 256 million⁽²⁾, an increase of 19.6% compared to Q2 2009 ;
- Abroad, the evolution is also favourable with an increase of 14% at € 21 million⁽²⁾. The recovery of the activity in Spain (62% of international sales) mainly explained this positive development with an increase in Spanish sales of 28%.

Airport : +36.2%

This noticeable increase is also confirmed in Multiservices business : Q2 sales amounted to € 60,1 million⁽²⁾, up to 23.7%.

Airport activities contributed strongly to this positive evolution with Q2 sales up to € 44.3 million, an increase of 36.2%. As expected, this strong performance stems from the new contracts gained with the extension of the scope of intervention of Group Crit on Roissy and Orly. Without these new contracts and, despite a traffic air strongly impacted by the eruption of Icelandic volcano, (Aircraft movements dropped by -8% in Q2 2010 in Roissy and Orly Airports), Q2 sales in airport business posted a limited decrease of 4.6% at constant scope.

Given this successful beginning of year, Group Crit reaffirms its confidence in its capacity to achieve a year of growth in activity and to improve its profitability.
