



**2006 Sales : +10.6%**

**Confirmed acceleration of growth in the fourth quarter : +13,7%**

In 2006, Group Crit sales amounted to € 1 298,9 M, posting an increase of 10,6% over the same period of 2005. At constant scope, growth increased by + 7,4% with sales of € 1.261,8 M.

This performance confirmed the sustained acceleration of growth in Q4 with sales of € 339,2 M€, posting an increase of 13,7%.

#### **Temp. business : +16,3% in Q4**

In Temp. Business, Q4 sales reached € 298,3 M vs € 256,5 M in Q4 2005, posting an increase of 16,3%. At constant scope, growth increased by 10,3% with sales of € 283 M (in which +9.9 % growth in France). It should be noted that over the same quarter, the growth of Temp. market in France increased at a lower level (less than 8%)

With Temp. Business sales of € 1129,5 M, posting an increase of + 10.9% (+7.4% at constant scope), the 2006 exercise was highlighted by the following actions:

- Reinforcement of international positions with acquisitions of the Spanish companies Tutor and Addenda (integrated respectively in May and July 2006). For the 2006 exercise, sales realized outside France represent more than 6% of the total sales of the segment (more than 8% on a full year basis)
- Continuation of the selective program of branch openings in France with 23 openings over the year
- Reinforcement in the most dynamic sectors of the market allowing to largely compensate the automotive market decline
- Signature of new national agreements and sustained development in direct recruiting

On its core business, the 2006 exercise re-confirmed the Group Crit position of first independent temp. Business company in France, allowing it to reach new steps in its development plan and to be confident for 2007.

## Multiservices : + 8,5% in 2006

Multiservices business (13% of the total Group sales) reached sales of € 169,4 M, posting an increase of + 8,5%. The Airport business segment continued its sustained growth with sales of € 104,1 M€, posting an increase of 10%. The evolution is also positive in the engineering and maintenance business segment with an increase of +7,6% to € 54 M.

Based on this achievement, the group confirms a progression in results for 2006 and envisions 2007 with confidence.
