Group Crit achieved a very good half-year with sales amounting to € 719.5 million, up 18.9%. Q2 activity remained particularly dynamic despite a less favorable base effect. With sales of € 386.5 million, activity rose by 16.6% over the period.

These excellent performances, entirely in organic growth, confirmed the fact that the Group has reverted to steady growth in all of its business activities.

Temp. Business: up 21.2%

In Temp. Business (84% of total sales), H1 2011 amounted to € 605.7 million ⁽²⁾, up 21.2%.

With sales of € 325.4 million ⁽²⁾, Q2 2011 activity rose by 17.4%, compared to a growth of nearly 19% in Q2 2010/Q2 2009.

France remained the major growth driver with H1 2011 sales of € 563.8 million ⁽²⁾ up 22.5%. This growth, higher than the growth in the French market, reinforces the strong dynamics of market shares gained. Abroad, H1 2011 sales increased by 6.4%, to € 41.9 million ⁽²⁾. The activity in Spain, despite a still adverse market situation, amounted to € 25.1 million (up 1.5%).

Multiservices : growth on all activities

Multiservices business also confirmed its growth in H1 2011 with sales of € 122.1 million ⁽²⁾, up 7.5%.

Airport activities sales (74% of total multiservices sales) amounted to € 90.6 million ⁽²⁾ vs. € 84.5 million in H1 2010, up 7.2%. On these activities, the second quarter has been very positive with a 10.9% increase in sales which amounted to € 48.8 million ⁽²⁾.

Engineering and Maintenance activities turned in a satisfying growth with H1 2011 sales of € 23.6 million ⁽²⁾, up 15.7%.

This successful first half-year allows the Group to reaffirm its confidence in its capacity to achieve a year of growth in activity and to improve its profitability.
