



## Second-quarter revenue : + 9.9%

Groupe Crit delivered a strong Q2, posting revenue of €429.9 million, a 9.9% increase of the €391.1 million recorded in the same period in 2013, (+5.4% on a like-for-like perimeter basis). Both France and international contributed to this growth. International operations (21.4% of total second-quarter activity) confirmed their trend with revenue growing by almost 25% to €92.2 million.

### **Staffing and recruitment division: + 7.3 % in France**

#### **International growth: + 28.9%**

Second-quarter revenue in the Staffing and recruitment operations (84% of total activity) grew by 11.5% to €361.6 million \*.

**In France**, despite a flat market, the group continues to increase its market share with second-quarter revenue rising by 7.3% to €280 million.

Thanks to these performances, half-year revenue in France increased by 6.4% to €511 million.

**Staffing International** operations grew strongly with second-quarter revenue rising by 28.9% to €81.6 million. Thanks to this excellent performance, staffing international half-year revenue increased by 26.2% compared to the same period in 2013. Both Spain and United-States contributed to this strong growth. In Spain, half-year revenue rose by more than 39% to €32.3 million. The US half-year revenue increased up more 29% to €99.2 million (65% of international Staffing and recruitment activity).

### **Multiservices division: another quarter of growth**

The Multiservices division posted half-year revenue of €138.7 million, increasing by 2%. Airport services (74% of activity for this division) half-year revenue grew by 3.5% to €102.8 million. Second-quarter increased by 3.6%, boosted by the activity in France with second-quarter revenue of €44.7 million, up 4.7%. In addition to this positive development of the activity, the beginning of the year was marked by the renewal of the airport licenses to operate on Roissy Charles de Gaulle and Orly airports and the expansion of the scope of action of the group at Roissy Charles de Gaulle Terminal 3. This success reinforces leadership acquired in France and opens up new development prospects for the Group.

Following these evolutions, Groupe Crit is confident in its growth dynamics and results for the remainder of 2014.
