Growth in Q2 International sales up 30%

The second quarter highlights an important step in Group Crit's activities: over the period, sales amounted to €391.3 million, an increase of 1.4% (-0.7% at constant scope and exchange rates).

This growth benefits from the significant improvement in activity in France and the sustained dynamics in international business. Outside France, Q2 sales increase by 30% to more than €74 million (19% of total sales).

With these positive evolutions, H1 sales amounted to €725.8 million, a limited decrease of 1.4%.

In the Temp. business, Q2 sales grew 1.1% to €324.3 million*, after Q1 sales down almost 5%. With this positive evolution, H1 sales stood at €599.7 million, down a slight 1.8%.

In France, after a decrease of 10.4% in Q1 sales, Q2 sales improved significantly. Over the period, sales amounted to €260.9 million, down 4.3%. On the same period, the Temp. market in France decreased by 9.5% (source : est. Prisme).

International sales amounted to €63.4 million up 31.4%. This strong growth was sustained by the contribution of Groupe Crit activities in North America, where sales grew above +50% to €40.5 million (+23.1% % at constant scope and exchange rates).

The multiservices business grew 5.6% in Q2 with sales to €73.3 million. Throughout the semester, the activity is up 1% compared to the same period of 2012 to €135.8 million. In Airport services (73% of sales for multiservices), sales, flat in Q1, increased by 3.4% in Q2 to €53.3 million. On this period, International sales continue to increase up 22% to almost €11 million.

In light of this positive evolution, Groupe Crit reaffirms its confident for the second part of the year. The successes in the United States also strengthen the Group's desire to implement new operations acquisitions allowing it to complete its presence in this market.
