



## Strong growth in Q3 2010 sales: + 19%

In Q3 2010, Group Crit sales amounted to €359 million, up to 19.1%. In the first 9 months 2010, sales were up to € 964.2 million, an increase of 16.2% compared to the same period in 2009.

This strong performance confirms, month after month, a solid development in the two business segments.

### Temp. business: +18% A sustained growth

In Temp. business, Q3 sales were up to € 301.8 million<sup>(2)</sup>, an increase of 17.7% at constant scope. The activity in France, which represents 92% of total sales, strongly contributed to this good third quarter performance with Q3 sales up to € 278.4 million, increasing by 18.7%. Abroad, sales amounted to € 23.4 million, up to 6.5%. Despite a still adverse market situation, the activity in Spain increased by 11%, with sales closed to €13.4 million.

### Multiservices: +27% Growing momentum in Airport activities

In Multiservices business, Q3 sales amounted to € 61.5 million<sup>(2)</sup>, an increase of 26.8%. This sustained growth benefits from a growing momentum in Airport activities with Q3 sales up to € 47.1 million<sup>(2)</sup>, an increase of 42.4%. After a first half year increasing by 32%, this strong performance confirms the growing contribution of the new contracts gained with the extension of the scope of intervention of Group Crit on Roissy and Orly.

Given this successful third quarter, Group Crit reaffirms its confidence in its capacity to achieve a year of growth in activity and to improve its profitability.
